We do this in a number of ways, including through questionnaires, recorded musical activities, artist logs and interviews with young people. All data collected is anonymised for the purposes of reporting.
- Britten Pears Arts agrees to be responsible for the safety and care of young people taking part in Group A activity during activity times. All adults employed by Britten Pears Arts to work with young people agree to an enhanced DBS check and also agree to abide with Britten Pears Arts' Safeguarding policies (available on request).
